RE: Ongoing closure of Vector Institute offices and Province of Ontario shutdown

Vector Institute Status

The Government of Ontario had previously announced a [Provincewide Shutdown](#) effective December 26, 2020.

As a result, **Vector Institute onsite operations in Suite 710, MaRS Centre West Tower will remain closed.**

This condition is expected to remain in place until the City of Toronto Public Health region changes its condition from grey ('Lockdown')

Work from Home Arrangements

Access to the office in order to retrieve business-critical items or equipment will be reviewed on a case-by-case basis. To request such access please contact the Office Services Manager, Vanessa Dunne, at vanessa.dunne@vectorinstitute.ai.

The Vector Institute's community will continue work-from-home arrangements throughout this period.
